Event Waiver:***

Everyone at the Latta Plantation and the North American Paranormal Society would like everyone to have a great and safe time during the paranormal investigation of the plantation. To do this, we have enforced a few rules that we would like everyone to follow so that this event may run smoothly.

1. Everything that happens (if paranormal activity does in fact take place) is 100% real. There is nothing staged or set up for the night's events. Anyone who is caught faking evidence, moving items around, making noises to pass off as paranormal, or anything like that, will be asked to leave the premises without a refund. We understand that everyone is here to participate in a real paranormal investigation and to do that, we need everyone's cooperation to ensure that everyone can have the same experiences.
2. The North American Paranormal Society has equipment set up throughout the various locations. There will be wires across the floors, so please watch your step. Also, please try not to block any of the cameras that are set up. The investigators will point out where things are so no one will accidentally knock them over or trip. Please be careful and please be respectful of the equipment set up.
3. If paranormal activity does occur, we ask that everyone please remain calm, there is no reason for panic. If people panic, people can get hurt and equipment can be broken. Remember, we are here to investigate the paranormal, if you run from it, you won't get the evidence you need to show that it is actually taking place. If for any reason you are feeling uncomfortable or need to step out for a moment, please let one of the investigators or one of the staff at the Latta Plantation know, and we will accommodate your request. Once you have regained your composure, you may come back to continue in the investigation.
4. Code of Conduct while on the investigation:
 - **No provoking**: We are not here to anger the spirits or upset them in any way; we are here to document their presence and any activity that may occur.
 - **No cursing**: Please be respectful when speaking to the spirits of the plantation, remember, they were once people as well and I'm sure you would not like someone coming into your home and using foul language at you.
 - **No Ouija Boards or Séances**: We do not allow Ouija boards during an investigation and if we see one, they will be taken and left in the main building of the plantation until you leave. This also applies to any and all things that are brought to the investigation to call forth or summon spirits. Again, this is not why we are here; we are not going to allow the conjuring of spirits as we don't know what could be called forth. The staff at the Latta Plantation also asks this of all of the participants in the investigation. If you bring certain items, (example: a cross) that help you feel protected, that's one thing, but using items for any kind of chanting, incantations, or séances is prohibited on the site.
 - **No running**: Again, we cannot stress this enough, please remain calm if things do happen.

- **Stay with your group:** When investigating the house or any location on the property, please stay together with your group, we do not want anyone wandering off alone for various reasons. If you are alone, no one can verify if activity happens to you in which case it's just as good as not happening at all. Also for safety reasons, if you are alone and you are hurt, no one is there to help you.
 - **Do not review evidence during the investigation:** We have almost lost evidence of critical nature due to the reviewing of it during an investigation. Please keep all evidence for review after the investigation is over.
 - **No Horse playing:** Anyone who is running, screaming, scaring others for fun or any kind of disturbance to the investigation will be asked to leave.
5. You will be on site of a historic location, so please show the proper respect for the property and do not damage anything or sit on any of the furniture throughout the house.
 6. Please remember that you are participating on this investigation on your own will. The Latta Plantation and the North American Paranormal Society will not be held liable for anyone who might get hurt. There are measures in place to make sure this does not happen, but we cannot watch everyone all the time, so please be cautious while walking the grounds for your own safety.
 7. All refunds are handled through the Latta Plantation staff, the North American Paranormal Society is not in charge of refunds, so please do not ask them. **If you are caught breaking any of the rules and code of conduct stated above, you will be asked to leave and you will not be granted a refund for the event.**

We want everyone to have a great time while investigating the historic grounds of the Latta Plantation and hope that you receive great evidence from the night's events. If you do find any evidence that you wish to share with the public, please allow Latta Plantation to review evidence prior to posting. The North American Paranormal Society also would be glad to help you review evidence to ensure its validity.
