LIABILITY RELEASE, MEDICAL RELEASE, AND INDEMNIFICATION AGREEMENT

In consideration for being permitted by Latta Place Inc. to participate in said program titled “The Battles of Charlotte and The Battle of the Bee’s,” I hereby waive, release, and discharge any and all claims and damages for personal injury, death, or property damage which I may sustain or which may occur as a result of my participation in the above named program.

I understand and agree that:
